Subject: Your request for clarification on UK membership of the NWWAC after 29 March 2019

Your ref. your letter of 4 September 2018

Dear Mr. Brouckaert,

Thank you for your above-mentioned letter regarding the status of UK member organisations in the North Western Waters Advisory Council (NWWAC) after 29 March 2019. In particular, you enquire whether UK members would be able to continue as full members of the North Western Waters Advisory Council until the end of the transition period.

As it stands now, the Draft Withdrawal Agreement provides for a transition period until 31 December 2020. During this period, the principle would be that the UK would retain the same rights and obligations as it has as a Member State, and will consequently be fully bound by the CFP.

However, there are some exceptions, such as participation in the decision-making processes from which it will be excluded. A guidance document setting out practical implications related to withdrawal and transition – including the participation of UK stakeholders in different EU fora – will be published after the Withdrawal Agreement has been signed.

In addition, I would like to remind the following: in case no withdrawal agreement would be ratified, the United Kingdom would become a "third country" from 30 March 2019. In such a situation however, UK representatives of the fisheries sector and of other groups of interest that have a fishing interest in the area or fisheries covered by an Advisory Council may be invited to participate to meetings as active observers¹. Councils may also contribute to the travel and accommodation expenses of those observers under the same conditions that they apply for their members².
